2. Provide sink and or stove top information to Technician.
3. Farm sinks must be installed prior to template appointment.
4. Ensure customer supplied sinks and all appliances are available and on site.
5. Clear all countertops in order to ensure accurate measurements.
6. Have suitable protection for flooring (non-slip) if necessary.
7. Do no rearrange or move cabinetry after template appointment.
8. Homeowner responsible for decision making must be present and remain on site for the duration of the template appointment.
9. Ensure all cabinetry is fully secured, level, plumb and true. Any items that are identified at the template appointment as needing attention must be done prior to installation appointment.
10. If you have any questions or concerns please do not hesitate to contact your Sales Representative.
11. Faucets must be on site prior to template
12. Lead time on template is 1-3 weeks

INSTALL:



Granite Waiver

General Information: Granite is a natural, igneous stone that is quarried from mountains all over the world. It can vary in color and patterning which attributes to the beauty and uniqueness of natural stone.
 Seams: The seams in a granite countertop may be seen and may be felt. Every effort is made to minimize the visual impact. Due to limitations of the slab size, large islands and counter runs may require additional seams. Final seam placement will be determined during production and can be viewed and approved prior to fabrication. According to industry standards, seams may be up to 1/8 inch wide. Differing structure and patterns of individual granite products can increase the likelihood of visible seams.
 Finish: As a natural stone, granite is prone to variations in color, pattern, and density. Granite surfaces can be polished, matte, or leathered.
 Staining: Granite is stain resistant, but it is still recommended to seal the stone regularly and clean up spills quickly.
 Cleaning: Warm, soapy water or a PH neutral household cleaner are suitable for cleaning your granite countertop. Granite is susceptible to acids and abrasive cleaners which can strip the sealer.
 Scratches: Granite is highly scratch resistant and will not show wear from daily use.
 Heat: Granite is heat resistant and can withstand the heat of hot pots and pans; however, it is recommended to use trivets to ensure protection of your countertop.
